Conditions of membership

Basic information

The following rules and regulations are general membership conditions that have been adopted by the board of the association. The Articles of Association and the terms and conditions of the SG Stern Deutschland e.V. basis on these general conditions of membership. Both the statute and Terms of Use as well as the general membership conditions are accepted by the member with the signing of the Declaration as binding. The articles of association are available for inspection online at www.sgstern-stuttgart.de.

1. Membership

The membership in the association, also automatically in SG Stern Deutschland e.V., can be acquired by employees and retired of Daimler AG and their spouses and family members. The membership in the association can also be acquired by any natural person. The membership in the association can also be acquired by legal persons who are recognized as charitable. Each member acquires an identical membership in the association, that is irrespective of the residence retains validity. Membership starts to effect after written affirmation by the executive committee. The application of an underaged must be approved by the legal representatives. The notice of withdrawal of the membership by the executive committee shall be notified in writing, but does not require justification. Membership begins with the affirmation of the membership application, by the executive committee. It provides the opportunity to join the sport sections of the club. The memberships of the sport sections are defined for one year by member. Further memberships of sports sections are possible at all times. Each member receives the membership card with the welcome letter and it will be re-issued annually. Pensioners have to include a copy of their retirement card when applying for membership. Termination of membership will occur due to notice of withdrawal, debarment or death. With the termination of membership in the association - for whatever reason - also the membership in the SG Stern Deutschland e.V. is determined. The notice of withdrawal has to be carried out by written explanation to SG Stern Stuttgart, Fritz-Walter-Weg 19, 70372 Stuttgart until September 30th and will be valid as of the end of the year. The notice of withdrawal can only be explained with a notice period of three months to the end of a calendar year (September 30). To comply with the notice, the timely access of the notice is necessary. Upon termination of membership, for whatever reason, all claims from the membership ratio. Any outstanding obligations arising from the membership ratio, especially outstanding contribution obligations remain unaffected. If a member leaves the club during the continuous calendar year, the member is not entitled to proportionate or complete recompense of the effected payment.

2. Fee

The payment of dues are usually by direct debit or debit procedure. For this purpose, the association has a claim against any member for grant of a SEPA Direct Debit mandate. The SEPA Direct Debit mandate is to be given in writing to the association with the declaration of accession. The collection of the membership fee is carried out on 15 February of each calendar year by direct debit. Should the 15 February shall not fall on a business day, the debit will take place on the next banking day. Members who join during the year, pay a pro-rata fee for the remaining months of the year from joining the association on 15 October or at a later, at the following year. The amount of the membership fee is defined in the declaration of accession. The membership marked rates with an asterisk (*) charge, if applicable, additional course, lane or field fees. Further information provides the contact person of the particular sport sections. Charge for return debit note as well as reminder charges of not accurately timed membership fee bears the member. Membership services and performances as well as a raise of the membership fee can be determined by the delegate congregation.

3. Rights and duties

With the admission to the association, the member accepts the statute of the SG Stern Deutschland e.V. and existing association orders and decisions as binding and submits it. The same applies to the statutes of associations and organizations in which the association or the SG Stern Deutschland e.V. is member. The members are authorized to use facilities and arrangements of the club. The participation at sport section meetings is open to every member of the sport section. Every member is entitled to suffrage. Resolutions of its organs are binding on the members. Change of personal data or bank account has to be conveyed to the club immediately. Charges which are generated by conveyed changes bears the member.

4. House rules and terms of use

The participants of the proposals of the club accept the house rules of the utilized sport locations. These are listed at www.sgstern-stuttgart.de.

5. SportCard The membership card of SG Stern Stuttgart comes to effect as the SportCard of SG Stern Stuttgart immediately and authorizes every member

to the club's benefits. You can find our co-operation partners and accurate terms at www.sgsternstuttgart.de.

6. Data privacy

To fulfill the purposes and tasks of the association personally identifiable information about personal or material circumstances of members in the association are stored in compliance with the statutory provisions, transmitted and changed. Addresses and telephone numbers of members may not be disclosed. For assistance, counsel and information about club events as well as for accurate and economic execution of membership payment, the deduction information of Daimler employees are automatically adjusted to already existing staff data and account data at the trust and are updated as needed.

7. Insurance

We strongly advice every participation to conclude a personal compensation and casualty insurance with enclosure of sports risk. Further information about insurance and the loss form are available at www.sgstern-stuttgart.de.

8. Validation

If particular terms and conditions of the membership are completely or partly futile, the effectivity of the remaining integral part of the contract will not be affected by this. Deviant mediated agreements are only effective when arranged in written form. With announcement of new conditions of membership, validity of all former agreements will expire.

9. Place of execution and place of venue

Place of execution is the announced site of the activity. Stuttgart is agreed on that place of venue. Should SG Stern abstain from assertion of the membership conditions at hand in singular cases, this does not affect membership conditions in general.

Business conditions of SG Stern aktiv

1. Membership

- a) The membership starts each with the 1st of a calendar month. With deviant start of the workout before the effective date, a proportionate monthly contribution will be charged for this period.
- b) The transponder has to be brought to each workout. In case of loss of the transponder the purchase of an alternative transponder is obligatory.
- c) The participation at an appointment of briefing is compulsive before acceptance of work-out for every member of the sport section fitness.
- d) The membership extends without any additional application for respectively 6 months, if not recalled in due time by member. Deviant therefrom, memberships with 6-months retention extend respectively for 3 months and memberships with 1-month retention for another month accordingly.
- e) Discharge occurs by written explanation to SG Stern aktiv, Fritz-Walter-Weg 19, 70372 Stuttgart. It is asked to send the discharge by registered mail. The discharge can alternatively be delivered in person. The member receives an acknowledgement of the discharge.
- f) The cancellation period depends on the retention of the agreement. In case of 6-month retention or more, the cancellation period is 6 weeks before expiration of the contract. In case of shorter retention the cancellation period is 2 weeks before expiration of the contract.
- g) Exceeding discharges are only possible in exceptional cases and have to be proved.
- h) The discharge of the sport section SG Stern aktiv does not affect the membership of SG Stern Stuttgart. Please note that a separate notice of termination according to the articles of association is obligatory.
- i) In case of job-related temporary employment abroad or longer disease, an idle period can be arranged in anticipation. For the idle period, a document of proof has to be brought forward. No fee will be charged during this period. The contract retention extends about the length of the idle period.
- j) The contract is not transferable to third parties.

2. Fee

The collection of the membership fee is conducted at each 1st of the calendar month. In case of return debit note, all charges have to be borne by member. The sport section fees are liable to an annual premium adjustment. The monthly fee of the sport section SG Stern aktiv can be increased about 4,- € to each January 1st of a year. The new fees are announced at least 6 weeks before the end of the year.

3. Pay scale

The "clever and smart"-scale contains the workout period Monday until Friday, respectively until 16.00 o'clock and after 20.00 o'clock; Saturday, Sunday and statutory holidays.
